Mayor Colleen Whitlow called the Regular Meeting of the Board of Trustees to order at 6:00 p.m.

4. Review and Approve Agenda

*Motion was made by Mayor Pro Tem Cartwright, seconded by Trustee Schranz, to approve the agenda.

5. Staff Report: Town Manager Report

a. Manager Report

Town Manager Helen Migchelbrink discussed the Board Retreat 6/17; Community Center Ribbon Cutting 6/24; Comcast is going live in Liberty Ranch and Hunters Cove in July.

6. Informational Items

a. 2024 Pavement Management

Manny Windhorst Pavement Management Program Manager presented the 2024 Pavement Management program.

b. Police Update

Police Chief Brent Newbanks discussed Flock cameras and their use in and around Mead.

c. Citizens' Initiative Marijuana

Administrative Services Director / Town Clerk Mary Strutt discussed the citizens' initiative process and the history of marijuana laws in Mead. Based on the initiative submitted, the Board directed staff to draft marijuana regulations to be referred to the November 5, 2024 election.

7. Proclamations

- a. Flag Day June 14, 2024 and National Flag Week June 9-15, 2024

Motion was made by Mayor Pro Tem Cartwright, seconded by Trustee Adams, to authorize Mayor Whitlow to sign the Proclamation for Flag Day June 14, 2024 and Flag Week June 9-15, 2024. Motion carried 7-0, on a roll call vote.

Motion was made by Trustee Harris, seconded by Trustee Brodhead to adopt Resolution No. 51-R-2024 – A Resolution of the Town of Mead, Colorado, Setting Forth Certain Findings of Fact and Conclusions as to the Annexation of Certain Property Known as the AMK Annexation based on a finding that all applicable criteria for annexation have been satisfied, as detailed in the Agenda Item Summary report prepared for the June 10, 2024 Board Meeting. Motion carried 7-0, on a roll call vote.

b. **Public Hearing: AMK Annexation and Establishment of Initial Zoning**

- i. Continuance of Public Hearing on Annexation and Zoning to July 29, 2024

Motion was made by Mayor Pro Tem Cartwright, seconded by Trustee Adams to open and continue the public hearing to consider approval of the ordinances to (1): annex certain territory known as the AMK Annexation to the Town of Mead; (2) establish the initial zoning for the AMK Annexation as light industrial' and (3) approve the AMK Annexation Agreement, which continued hearing shall be held on July 29, 2024, at 6:00 p.m. at Mead Town Hall, 441 Third Street, Mead, CO. Motion carried 7-0, on a roll call vote.

- b. Mayor Whitlow

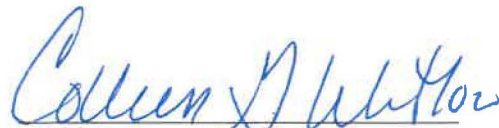
- i. CML District 2 Meeting

Mayor Whitlow discussed the CML District 2 Meeting and the Mead Area Chamber of Commerce Block Party.

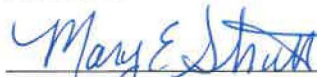
13. Adjournment
